GENERAL

DISCLAIMER

You acknowledge that if you are a youth leader or church leader and have completed the Youth Registration Form on behalf of a person under the age of 18 years of age, you have done so with the permission and consent of the child's parent/guardian and have been given the responsibility to care for the child at all times during Summer Camp. If you are a parent/guardian of a child attending Summer Camp, you confirm and acknowledge the child attends at their own risk and you allow this with full knowledge of the risks associated. Freedom Centre reserves the right to change any of the published Summer Camp details without notice and have the final say on any matter relating to Summer Camp.

PAYMENT

You acknowledge that the admission cost for Summer Camp is \$150 per student. Payments are made through the ticketing platform myetickets.co.nz. Payments can be made in full or in installments. The full admission cost is required for entry onto camp grounds.

SPONSORSHIPS

If you are unable to pay for deposit or total admission cost, you can apply for a sponsorship. Sponsorships are available to those who fill out the Sponsorship Application Form and identify being in financial hardship. By filling out the Sponsorship Application Form you acknowledge that you are unable to make payment for a portion or full cost for admission. You acknowledge that Freedom Centre has the right to approve or revoke sponsorship applications and not all applicants are guaranteed sponsorships.

SPONSORS

You acknowledge that by filling out the Sponsor Form for admissions that the initial admission cost for Summer Camp is \$150 per student. If you wish to sponsor a specific attendee(s) that is approved for sponsorship, you can identify the attendee(s) in the notes of your donation.

REFUNDS/TRANSFERS

LIABILITY RELEASE AGREEMENT

You understand that there are inherent risks involved in any camp activity, and you hereby release Freedom Youth, its staff and volunteer workers from any and all liability due to any injury, loss or damage to person or property that may occur during the course of their involvement with Freedom Youth Summer Camp.

MEDICAL TREATMENT CONSENT

You give consent to the Camp Supervisor(s) making the appropriate decision and taking any action to arrange for such procedures or treatments at the discretion of the Camp Supervisor(s). You give permission for the Camp Supervisor(s) to obtain emergency medical, hospital or ambulance assistance at anytime they consider necessary. You understand that every effort will be made for you or a listed emergency contact or relative to be notified before instituting such procedures. You acknowledge that you will be liable for any and all medical/hospital/ambulance costs and expenses incurred in your treatment. You also understand that while every reasonable precaution will be taken to ensure your practical protection, you hereby release and hold harmless Freedom Centre and Camp Management from any and all liability in the event of any injury, accident or misfortune, damage or loss that may occur to you and your property while present at Summer Camp.

EMERGENCY CONTACT

You acknowledge that if the emergency contact person is not able to be contacted for any reason, then the appropriate measures will be taken to provide medical treatment for the youth. This may be contacting your doctor, or if necessary calling an ambulance.

INVOLVEMENT CONSENT

You hereby give you consent for the registrant to participate in activities they may choose while attending the event. You agree and understand that Freedom Centre reserves the right to exercise its discretion to refuse to register any person upon medical and/or other grounds, without providing a detailed reason for doing so.

TRANSPORT CONSENT

You consent to Freedom Centre providing transport for your child to and from the venue and activities as set out in the curriculum for the day and you understand Freedom Centre will take all reasonably practicable steps to provide a safe environment for your child and ensure all vehicles are in a safe and working order.
